- h) The Trust may alienate by way of Sale, Lease, License, Mortgage or in any other manner deal with the movable or immovable properties of Trust which Trustees deem necessary in the interest of the Trust.

7 k) The funds, properties and assets of Trust shall vest upon the Trust and the Trustees perpetually and irrevocably affect them for the due fulfillment of the objects and purposes of the Trust. All funds and properties shall be taken into possession only in the name of Trust & no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividends etc.

7. MANAGEMENT OF THE TRUST:-

The management of the trust shall be vested in the founder trustees who shall be the trustees for their life time & hold the offices of chairman & secretary as mentioned under the terms rules & regulations. After their death their son Mr. Siddaling swamy Navali Hiremath shall be the trustee for life time by succession which shall continue for subsequent generations.

8. POWER OF THE TRUSTEES:-


The following powers shall be vested in the trustees for carrying out the day-to-day activities to fulfill the objectives of the Trust through office bearers i.e., Chairman & Secretary of the Trust.

a) To receive and collect the funds i.e., donation and grants etc., in cash and/or kind from the general public otherwise and to pass a valid receipt.

b) To open, maintain, operate and close accounts in any bank or banks as decided from time to time. The Accounts shall be operated jointly by chairman and Secretary or by a chairman or by a person authorized by the Charirman.

c) To initiate, defend, prosecute and compromise legal proceedings and to perform all such acts, incidental to them by themselves or through agents.

d) To appoint employees, agent and representatives, if necessary and take legal actions and appoint legal advisors/counsels for conducting disciplinary action against them including suspension & dismissal end anti establishment if found unsuitable.

e) The Chairman shall have the power to constitute Governing Councils and sub committees if necessary for the smooth and efficient functioning. Persons who are expert in the concerned field can be nominated as committee members. The Governing Council or sub committees shall not have more than 7 members. The Governing Council or Sub-Committees is authorized to run the day-to-day affairs of the projects or institution assigned to it.

f) The Chairman of the trust or his nominee shall preside over the meetings of the Governing Councils or Sub-Committees supervise and direct the activities of the Councils or Sub-Committees.

g) The Secretary of the Trust shall be the Secretary of the councils or sub-Committee. However, the activities conducted by the council or sub-committees require the approval by the chairman.

h) The term of the Governing Council or Committee shall be for a period of 3 (three) years. The Chairman has the power to re-nominate the members of the council or sub-committee.


i) The Chairman has the power to dissolve the councils or committees and to remove any member of council or sub-committee who is found acting against the interest of Trust, even before expiry of three year period without assigning any reason.

j) To lay down policies for prudent, efficient and effective administration and management of the educational institutions and other organizations run by the Trust.

k) The Chairman or Secretary shall have powers to sign all contracts, agreements, correspondences, deeds, statements and any other documents executed by or on behalf of the Trust.

l) The Trustees have powers to do all such acts and deeds which have not been specifically mentioned herein but which are found to be necessary and essential for fulfilling the objects of the Trust.

m) The rules and regulation shall be interpreted by the Trustees, whose decision shall be final and binding.

9. FUNCTIONS AND DUTIES OF OFFICE BEARERS:-

a) CHAIRMAN:-

The Chairman/his nominee will reside over the meetings, and implements the decisions of the Governing Councils/ Sub committees. He shall supervise & expand the activities of Trust.

b) SECRETARY:-

The Secretary shall be responsible to the Chairman. He shall execute the decisions and directions of the Chairman. 10. MEETINGS:-


a) The Governing Council shall meet as often as the circumstance requires transact the business of the Trust. However there shall be at least one meeting in a quarter.

b) A notice of at least 5 (five) days shall be given to call meeting of Governing Council but in urgent or emergency circumstances, a meeting may be called at a short notice.

11. ACCOUNTS:-

- A regular and proper accounts of all the receipts and expenses of trust shall be maintained by the Secretary along with documents and proper books of accounts subject to a statutory Audit by Chartered Accountant every fiscal year.
- The audited statement of the Trust and the institutions shall be placed before the governing Council as soon as possible but in any case not later than nine months from the last day of the previous year.
- The bank account/s shall be opened in the name of the Trust and operated by the Chairman or Secretary or by a person authorized by the chairman.
- The financial and official year of the Trust shall be from 1 April to 31 March.

12. INVESTEMENT OF TRUST:-

- The trustees shall invest all the money contributed to or received by the Trust by way of interest, purpose and objectives of the Trust to administer and develop the Trust.
- The investment of the surplus Trust shall always be in strict accordance with the provision of section 13(1) (d) read with the section 115) of the Income Tax Act, 1961.
- The trustee shall invest all money contributed to or received by Trust, all amount accruing by way of interest or otherwise to the Trust in any one of the following manners.
 - To be deposited in the Scheduled Bank or Co-op banks in the name of Trust.
 - To be invested in Post Offices.
 - To be invested in the securities mentioned or referred to in clause of section 20 of the Indian Trust Act., 1982 and section 13(5) of Income Tax Act, 1961.
 - To be invested strictly in accordance with the provisions of Income Tax Act, and rules framed there under governing investment of funds of the Charitable Trust.

13. INDEMNITY:-

All legal proceeding by or against Trust shall be instituted in the name of the Trust represented by the Chairman or Secretary.


15. DISSOLUTION OR WINDING UP:

Emphasizing against the misuse of the water, water development schemes would cover storage of water for agriculture purposes, for drinking purposes or animals and cattle. Getting financial help from the Government, Semi-Government Org., various types of voluntary organizations with the financial assistance of various agencies, implementing village development plants so that the common man is also benefited.

- i) The Trust may borrow or raise funds with or without the security from the bank, financial institutions or from individuals in any manner the Trustees deems necessary in the interest of the Trust and repay, the same.
- j) Negotiate with and enter into arrangements with any Government authority, Corporation, Board, University or Other public or private bodies, as may seem conclusive to promotions or accomplishment of the objects of the Trust or any of them and to apply for obtain, collect, receive such grants, loans, allowances, rights, concessions and privileges as may seem to comply with the objects and utilize the same.
- k) The funds, properties, assets and like of Trust shall vest upon the Trust and the Trustees perpetually and irrevocably affect for the due fulfillment of the objects and purposes of the Trust. 7. BOARD OF TRUSTEES :

10. TENURE AND FUNCTIONS OF THE OFFICE BEARER :

The office bearers of the Trust i.e., Chairman & Secretary shall manage the day-to-day affairs of the Trust. Their tenure shall be Five years and they are eligible for re-election.

11. POWER OF THE BOARD OF TRUSTEES :

ಉ ನೋ. ಅ. ಹುನಗುಂದ

The following powers shall be vested in the Board of Trustees for carrying on the day-to-day activities of the Trust to achieve the objectives of the Trust through office bearers i.e., Chairman & Secretary of the Trust.

- To receive and collect the funds i.e., donations and grants etc., in cash and/or kind from the general public otherwise and to pass a valid receipt.
- To open, maintain, operate and close accounts in any bank or banks as decided from time to time. The Accounts shall be operated jointly by President and Secretary.
- To initiate, defend, prosecute and compromise legal actions and appoint legal advisor, counsels for conducting all legal proceedings and to perform all such acts, incidental to them by themselves or through agents.
- To appoint employees, agent and representatives, if necessary. AND to disciplinary actions against them and to suspend or dismiss if found unsuitable.
- The Board of Trustees shall have the power to constitute Governing Council/s and Sub-committees if necessary for the smooth and efficient functioning. Persons who are experts having knowledge in the concerned field can be appointed as committee members. The Governing Councils or Sub-Committees shall not have more than 7 members. The governing council or Sub-Committees is authorized to run the day-to-day affairs of the projects or institutions assigned to it.
- The Governing Council or Sub-Committee shall have a Chairman nominated by the Board of Trustees, he shall preside over the meetings of the Governing Council or Sub-Committees supervise and direct the activities of the Council or Sub-Committee.
- The Secretary of the Board of Trustee shall be the Secretary of the council or Sub-Committee. However, the activities conducted by the council or sub-committee requires the approval and ratification by the Board of Trustees.

- h) The terms of the Governing Council or Committee shall be for a period of three years. The Board of Trustees have power to re-appoint or re-nominate the members of the council or sub-committee.
- i) The Board of Trustees by a simple majority have the power to dissolve the councils or committees and to remove any member of Council or sub-committee who is found acting against the interest of Trust, even before expiry of three years period.
- j) To lay down policies with regard to running of the educational institution and other organization pertaining to the administration and management prudently and efficiently in the interest of the Trust.
- k) The Chairman or Secretary shall have powers to sign the all contracts, agreements, correspondence, deeds, statements and any other documents executed by or on behalf of the Trust.
- l) The Board of Trustees have powers to do all such acts and deeds which have not been specifically mentioned herein above, but which are found to be necessary and essential for fulfilling the objects of the Trust. And the Board of Trustees is fully empowered to carryout the aims and objects of this Trust in any manner it deems fit.
- m) The rules and regulations be interpreted by the Trustees, whose decision shall be final and binding.

12. FUNCTIONS AND DUTIES OF OFFICE BEARERS :

a) CHAIRMAN :

The Chairman presides over the meetings, and implement the decision of the Board of Trustees. He shall supervise, expand the activities of Trust.

b) SECRETARY :

The Secretary shall be responsible to the Chairman and Board of Trustees. He shall execute the decision and directions of the Board of Trustees and Chairman. The Secretary shall be in-charge of and responsible for the safe custody of all records relating the Trust and its properties. He shall call and commence the meeting under the direction of the Chairman and maintain regular records of all proceedings of each meetings. All correspondence and all financial statement and returns required in connection with management of the Trust will be carried and prepared by the Secretary.

13. MEETINGS :

- ೧ ನೋ. ಅ. ಹುನಗುಂದ
- The Board of Trustees shall meet as often as the circumstance requires to transact the business of the Trust. However there shall be at least one meeting in three months.

 - The decision of the meeting unless otherwise stated shall be by majority vote of the Trustee Present.
 - The Chairman shall preside over the meetings, in his absence any member can be chosen among the Trustee to preside over the meeting.

QUORUM :

- The quorum for any meeting shall be the attendance of two numbers of Trustees. If the quorum is not present within one hour of the stipulated time at the meeting, the same shall stand adjourned by one week. In the adjourned meeting, if the number of Trustees is less than the requisite number as stated above shall be treated as sufficient quorum for the meeting.

13. ACCOUNTS :

- A regular and proper accounts of all the receipts and expenses of trust shall be kept, maintained or shall cause to be kept and maintained by the Secretary and also maintain documents and proper books of accounts subject to audit by Chartered Accountant in a year.
